1	<p>Providing, Supplying and Fixing Green Guard certified Zebra roller blind of M/a M2M /M/s NL Blinds (Essence collection - Dim-out collection) or equivalent custom to specific sizes, controlled manually with chains and weights having best quality 100% polyester fabric curtain with matching colour cassette of approved colour, shade and pattern, UV protection, insulation and energy saving fabric treated to resist stains and minimise dust built up, multilevel light control, multilevel light and privacy control, gentle wash. Lightweight fabric to allow maximum light, diffusion including suitable MS bracket, plastic bead chain. The arrangement shall have minimum 38mm top aluminium with 3M tape, bottom aluminium white powder coated with moulded plastic with epoxy and all types of accessories etc., complete all as per the manufacture specifications and as directed by the EIC.</p> <p>ROLLER BLIND SYSTEM: The assembly shall be aesthetically made and shall be sleek, compact, and fitted with best workmanship manner. The Blind system shall consist of a powder coated aluminium tube of minimum 38 mm diameter with provision of fabric clamping. The basic operation of fabric is rolling up and down through a beaded chain drive system with built in drive gear and an over run brake system. The fabric shall roll neatly onto the roller tube accumulating the fabric in one single linear tube.</p> <p>The side brackets are universal type suitable both for wall and ceiling mounting. The bottom end of the fabric is rolled over an oval shape aluminium tube with provision to lock the fabric. The system shall be fixed with Aluminium pelmet channel with chord and acrylic chord weight.</p> <p>Zebra blinds shall provide adjustable light filtering options, thereby creating a balance between privacy and natural lighting and shall offer enhanced privacy with their alternating sheer and solid panels. The assembly used to be in two or more separate sections for length as specified for locations.</p> <p>Accessories: Zebra cassette for roller blinds, end cover with blind components, blind head rail. Plastic bead chain, counterweight & accessories, head & bottom rail, Aluminium tube for roller with all mechanism and rollout with manual ABS plastic control unit etc.</p> <p>Chain material : Endless beaded chain with 4.2mm plastic bead moulded on 2.2mm thick polyester coat.</p> <p>Fabric : Fabric shall be selected from best quality 100% polyester woven fabric. The openness factor shall be of 3%. Fabric shall have specialized properties such as fire retardant, no harmful VOC or hazardous substances will be released to the environment in quantities that are recognized as potentially dangerous to occupants of building.
