TENDER FOR OPERATION AND MAINTENANCE OF SEWAGE TREATMENT PLANT

Providing Annual Maintenance Contract for Operation and Maintenance of New Generation Sewage Treatment Plant of capacity 11.5 cubic mtr. at International Centre for Theoretical Sciences of Tata Institute of Fundamental Research at Survey No.151, Shivakote Village Hessarghatta Hobli, and Bengaluru North.

Administrative Officer, ICTS-TIFR, Survey No 151, Shivakote Village, Hessarghatta, Bangalore North, Pin – 560 089, on behalf of the DIRECTOR, ICTS, invites sealed tenders (in two bid) from eligible contractors for the work and details as given below:

1. WORK: Providing Annual Maintenance Contract for Operation and Maintenance of New Generation Sewage Treatment Plant of capacity 11.5 cubic mtr. at International Centre for Theoretical Sciences of Tata Institute of Fundamental Research at Survey No.151, Shivakote Village Hessarghatta Hobli, and Bengaluru North.

- i. Estimated Cost of the Contract – Rs. 23.3 Lakhs per annum
- ii. E.M.D: Rs.46,000/- (Rupees Forty Six Thousand only)
- iii. Security Deposit: Security Deposit @ 10% of the contract value.

2. ELIGIBILITY/ QUALIFICATION:–

- A. Contractor should have a minimum 2 (two) years of experience in operation and maintenance of Sewage Treatment Plant of capacity 10 cubic mtr.
- B. Preference will be given to companies having national presence
- C. The agency shall have executed or be executing a single contract of minimum **Rs. 21 lakhs per annum** or two contracts of minimum **Rs. 10.5 lakhs per annum** or three contracts of minimum **Rs. 7 lakhs per annum** during the **last three year period**.
- D. The bidding agency should have experience (at least one contract in the last 2 years) in providing similar services to Public Sector Companies/Government Departments / Research Organizations / Reputed Private Sector Companies.
- E. Either the Registered Office or one of the Branch Offices of the bidder should be located in Bangalore.
- F. The bidding agency should have its own Bank Account.

Bidders must submit documentary proof in support of meeting the minimum qualification criteria. A simple undertaking by the bidder for any of the stated criteria will not suffice the purpose. All documentary proof must be listed on the letter head of the company and enclosed in a cover, to be submitted with the proposal.

- A. The bidder should have a valid **PAN number** issued by the Income-Tax Authority.
- B. The bidder should have a valid **Registration Certificate** of the firm / agency / Company.
- C. The bidder should have a valid **License** issued by the Competent Authority.
- D. The bidder should have valid **ESI & PF** registration certificate.
- E. **Security Considerations:** The persons deployed by the agency should NOT have any adverse police records/ criminal cases against them. The agency should make adequate enquiries about the character and antecedents of the persons whom they are deploying.
- F. Having regard to the scope of work, qualification, training and experience that are required for the job, the contractor should offer such emoluments and benefits to the people to be employed by him which takes into account:
 - a) The Qualification, Training and Experience of the deployed personnel.
 - b) Annual increase in Salary on account of revision of Basic Wages + V.D.A.
 - c) Emoluments which are well above the minimum wages as prescribed under the Minimum Wages Act.

3. TENDER DOCUMENTS CAN BE PURCHASED from 21.09.2016 to 13.10.2016 between 10:00 hrs and 17:30 hrs. on all working days from the Office of ICTS-TIFR, Survey No. 151, Shivakote, Hessarghatta, Bengaluru-560 089. Tender documents can be downloaded between these dates and tenderers who download the document from the portal/website should enclose the tender fees along with Technical bid.

4. COST OF THE TENDER DOCUMENTS (Non-refundable) is Rs.1000/- (Rupees One Thousand) in the form of Cash or Demand Draft drawn in favour of "INTERNATIONAL CENTRE FOR THEORETICAL SCIENCES", payable at Bangalore.

5. PROSPECTIVE AGENCIES TO SATISFY THEMSELVES of fulfilling all the NIT criteria before submission of the tender. Centre reserves the right of Non- issue/ Non- consideration of tender documents of the agencies who are not fulfilling the NIT stipulations and/ or having adverse report on the works carried out by them in the past.

6. PRE-BID MEETING shall be held on 03/10/2016 at 11.00 hrs at the office ICTS-TIFR, Survey No. 151, Shivakote, Hessarghatta, Bengaluru-560 089.

7. SUBMISSION OF TENDER: The tender for the work shall be received up to 15:00 hrs. on 14/10/2016 at the Office of ICTS-TIFR, Survey No. 151, Shivakote, Hessarghatta, Bengaluru - 560 089 and shall be opened at 15:30 hrs, on the same day.

The tenders should be submitted in two sealed covers.

1. The **First sealed cover - COVER I** should be superscribed "Technical Bid" and should contain Annexures A-E duly accepted, signed by authorised signatory with seal .

The cover shall also contain the following documents:

- (i) Company profile including previous experience of manpower deployment to government Departments, Multi - National companies, etc. Please attach copies of Work Orders, Completion Certificate, etc.

- (ii) Acceptance of terms and conditions specified in these tender documents.
- (iii) Demand Draft /Bank Guarantee in lieu for Earnest Money Deposit.
- (iv) Solvency Certificate issued by your banker.
- (v) Deployment pattern of Personnel including the number of Skilled and unskilled technicians to be deployed.
- (vi) Work Order copy of a single contract worth **Rs. 21 lakhs per annum** or two contracts of **Rs. 10.5 lakhs** or three contracts of **Rs. 7 lakhs** or more during the last three year period.
- (vii) Copies of valid PAN number issued by the Income-Tax Authority, Registration Certificate of the firm /agency/Company and proof of 2 years' experience in providing Operation and Maintenance of STP in reputed organisations.

2. The **Second sealed cover - COVER II** superscribed '**Price/ Financial Bid**' should contain **Annexure F**.

- The above mentioned two covers shall be sealed on the outside with wax seal bearing the logo/name of the company submitting the bid.
- These two covers shall be again put into a single wax sealed cover superscribed "**Tender for Operation and Maintenance of Sewage Treatment Plant**" at ICTS Campus, Survey No 151, Shivakote Village, Hessarghatta Hobli, Bangalore North, Pin 560089. This should be addressed to **Administrative Officer, ICTS-TIFR, ICTS, TIFR, Survey No 151, Shivakote Village, Hessarghatta, Bangalore North, Pin – 560 089** and shall be sent by post/courier/hand delivery so as to reach before the prescribed time.

The Bids will be opened on 14 October 2016 at 15.30 hours.

On the date of tender opening (**i.e. on 14 Oct 2016**), the Bids shall be opened in the presence of attending tenderers. The financial bids of the bidders who meet all the Technical NIT Stipulations only will be considered for further process.

In case the last date of sale/ receipt of tender are declared as holiday, the respective dates shall be treated as postponed to the next working day accordingly.

8. THE CENTRE RESERVES THE RIGHT to verify the particulars furnished by the applicant independently and accept/ reject the tender without assigning any reason thereof.

9. IF ANY INFORMATION FURNISHED by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering / taking up works in ICTS.

10. The intending bidders are advised to visit the ICTS site to see the available infrastructure before submitting their offers.
