4	GENERAL CLAUSES OF CONTRACT (GCC)
4.1	In the event of the contract being determined <b>or rescinded</b> under the provisions of any of the clause/ condition of the agreement, the performance guarantee shall stand forfeited in full and shall be absolutely at the disposal of the DIRECTOR-ICTS.
4.2	Clause 1A para 1, Page No.6
	The person(s) whose tender may be accepted (hereinafter called the contractor) shall permit Government at the time of making any payment to him for work done under the contract to deduce a sum at the rate of 5% of the gross amount of each running bill till the sum will amount to security deposit of 5% of the tendered value of the work.
4.3	DEVIATION, EXTRA ITEMS AND PRICING:
	In the case of extra item (s) (items that are completely new, and are in addition to the items contained in the contract), the contractor may within fifteen days of receipt of order or occurrence of the item (s) claim rates, supported by proper analysis, for the work and the engineer-in-charge shall within

- one month of the receipt of the claims supported by analysis, after giving consideration to the analysis of the rates submitted by the contractor, determine the rates on the basis of the market rates and the contractor shall be paid in accordance with the rates so determined.
- 4.9.2 In the case of substituted items (items that are taken up with partial substitution or in lieu of items of work in the contract) the rate for the agreement item (to be substituted) and substituted item shall also be determined in the manner as mentioned in the following para.
- 4.10 | Carrying out part work at risk & cost of contractor:

#### If contractor:


- i) At any time makes default during currency of work or does not execute any part of the work with due diligence and continues to do so even after a notice in writing of 7 days in this respect from the Engineer-in-Charge; or ii) Commits default in complying with any of the terms and conditions of the contract and does not remedy it or takes effective steps to remedy it within 7 days even after a notice in writing is given in that behalf by the Engineer-in-Charge; or
- iii) Fails to complete the work(s) or items of work with individual dates of completion, on or before the date(s) so determined and does not complete them within the period specified in the notice given in writing on that behalf by the Engineer-in-Charge. The Engineer-in-Charge without invoking action under clause 3 may, without prejudice to any other right or remedy against the contractor which have either accrued or accrue thereafter to Government, by a notice in writing to take the part work/part incomplete work of any item(s) out of his hands and shall have powers to:(a) Take possession of the site and any materials, constructional plant, implements, stores, etc., thereon; and/or(b) Carry out the part work / part incomplete work of any item(s) by any means at the risk and cost of the contractor. The Engineer-in-Charge shall determine the amount, if any, is recoverable from the contractor for completion of the part work/ part incomplete work of any item(s) taken out of his hands and execute at the risk and cost of the contractor, the liability of contractor on account of loss or damage suffered by Government because of action under this clause shall not exceed 10% of the tendered value of the work. In determining the amount, credit shall be given to the contractor with the value of work done in all respect in the same manner and at the same rate as if it had been carried out by the original contractor under the terms of his contract, the value of contractor's materials taken over and incorporated in the work and use of plant and machinery belonging to the contractor. The certificate of the Engineer-in-Charge as to the value of work done shall be final and conclusive against the contractor provided that action under this clause shall only be taken after giving notice in writing to the contractor. Provided also that if the expenses incurred by the department are less than the amount payable to the contractor at his agreement rates, the difference shall not be payable to the contractor. Any excess expenditure incurred or to be incurred by Government in completing the part work/ part incomplete work of any item(s) or the excess loss of damages suffered or may be suffered by Government as aforesaid after allowing such credit shall without prejudice to any other right or remedy available to Government in law or per as agreement be recovered from any money due to the contractor or any account, and if such money is insufficient, the contractor shall be called upon in writing and shall be liable to pay the same within 30 days. If the contractor fails to pay the required sum within the aforesaid period of 30 days, the Engineer-in-Charge shall have the right to sell any or all of the contractors' unused materials, constructional plant, implements, temporary building at site etc. and adjust the proceeds of sale thereof towards the dues recoverable from the contractor under the contract and if thereafter there remains any balance outstanding, it shall be recovered in accordance with the provisions of the contract. In the event of above course being adopted by the Engineer-in-Charge the contractor shall have no claim to compensation for any loss sustained by him by reason of his having purchased or procured any materials or entered into any engagements or made any advance on any account or with a view to the execution of the work or the performance of the contract."
- 4.10 The contractor shall also abide by the provision of the Child labour (Prohibition & Regulation) Act 1986.
- 4.12 No labour below 14 years: No labour below the age of 14 (fourteen) years shall be employed on the work.

#### 4 13 LEVY/TAXES PAYABLE BY CONTRACTOR:

i) GST, Building and other Construction Workers Welfare Cess or any other applicable tax or cess in respect of this contract shall be payable by the contractor and the Government shall not entertain any claim whatsoever in this respect.

#### SPECIAL TERMS AND CONDITIONS

- 1. Makes of various materials to be used by contractors will be according to the list of approved makes given. No other makes will be used by the contractor-
- 2. Contractor will first get the sample approved by ICTS Engineer before procuring the material in bulk and incorporating it in the work.
- 3. Contractor will be paid based on units specified in the tender. No extra measurement factor will be applied for the measurement Contractor so desires, he/she can visit the site and see the actual site before quoting.
- 4. Contractor will arrange all safety measures and Covid -19/pandemic guidelines at his own cost and will take all safety measures. If it is observed that work is proceeding without adequate safety precautions, work may be stopped by the Engineer. And in such cases, contractors will be solely responsible for the delay and its consequences thereof.
- 5. Electrical power: -Construction electrical power will be supply to the contractor at free of cost at one convenient point. Contractors shall take all necessary safety precautions in carrying electrical power as the campus has a residential colony and kids play around.






Approximately 1200mmx900x450mm deep high wall Storage unit 2 Nos.




Fornt view with 6 equal sized shutters.


