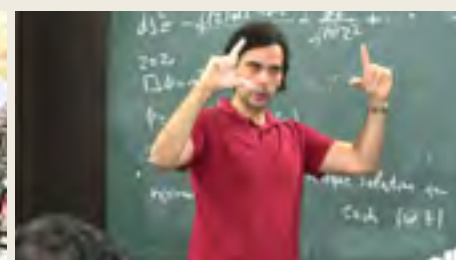

ICTS was created in 2007 with three main goals: to conduct high quality in-house research in theoretical sciences; to bring together scientists from all over the world, through its programs, to aid them solve the most challenging questions posed by nature; to stimulate and harness the young minds of India and to spread scientific temper and knowledge in the civil society.

ICTS is a centre of the Tata Institute of Fundamental Research that receives core funding from the Department of Atomic Energy, Government of India.
